MEMORANDUM OF ASSOCIATION (Form No. INC-13)

[Pursuant to rule 19(2) the Companies (Incorporation) Rules, 2014].

1. The name of the company is "T3S FOUNDATION".

- **2.** The registered office of the company will be situated in the state of **CHANDIGARH**.
- **3.** The objects for which the company is established are:

a) Education:

(i)To impart education by running educational institute(i.e. primary, higher & boarding schools, Colleges of art, science, management, technical & non-technical , medical & non-medical & Others)to provide education to all sections of the society at no profit no loss basis

(ii) To promote skill/competency development programs as per Govt. of India & State Govt. policies& guidelines

b) Social Welfare:

(i) To provide free education, free health camps, sports promotion by imparting free Sports training

(ii)To organize programs for the awareness of Environment protection, Traffic rules& regulations

(iii)To provide assistance to old/elder people & physically handicapped/disabled people Of the society

(iv)To organize women empowerment programs to educate women about Legal Rights/laws etc.

c) To do all such other lawful things as considerednecessary for the furtherance of the above objects

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by itsmembers or others, any regulation or restriction which, as anobject of the company, would make it a trade union.

4. The objects of the company extend to the whole of India

5.(i) The profits, if any, or other income and property of thecompany, whensoever's derived, shall be applied, solely forthe promotion of its objects assetforth in this memorandum.

(ii) No portion of the profits, other income or property aforesaidshall be paid or transferred directly or indirectly, by way ofdividend, bonus or otherwise by way of profit, to personswho, at any time are, or have been, members of thecompany or to any one or more of them or to any personsclaiming through any one or more of them.

(iii) No remuneration or other benefit in money or money'sworth shall be given by the company to any of itsmembers, whether officers or members of the company ornot, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, orreasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by thecompany in good faith of prudent remuneration to any ofits officers or servants (not being members) or to anyother person (not being member), in return for anyservices actuallyrendered to the company.

(v) Nothing in clauses (iii) and (iv) shall prevent the paymentby the company in good faith of prudent remuneration toany of its members in return for any services (not beingservices of a kind which are required to be rendered by amember), actually rendered to the company.

6. No alteration shall be made to this memorandum of association or to the articles of association of the companywhich are for the time being in force, unless the alteration hasbeen previously submitted to and approved by the Registrar.

7. The liability of the members is limited.

8. FOR COMPANIES LIMITED BY SHARES

The share capital of the company will consist of Rs.100000/-(One Lac only) divided into10000(Ten Thousands only) shares of 10/-rupees each.

9. True accounts shall be kept of all sums of money received and expended by the company and the matters in respect of whichsuch receipts and expenditure take place, and of the property, credits and liabilities of the company; and, subject to any reasonable restrictions as to the time and manner of inspectingthe same that may be imposed in accordance with theregulations of the company for the time being in force, the accounts shall be open to the inspection of the members.

Once at least in every year, the accounts of the company shallbe examined and the correctness of the balance-sheet and theincome and expenditure account ascertained by one or moreproperly qualified auditor or auditors.

10. If upon a winding up or dissolution of the company, thereremains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to be objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereofcredited to the Rehabilitation and Insolvency Fund formed under section 269 of the Act.

11. The Company can be amalgamated only with anothercompany registered under Section 8 of the Act and havingsimilar objects.
